- 2. **FULLY** understand that hunting activities involve risks and dangers of serious bodily injury, which could include a permanent disability, paralysis and death.
 - a. These risks may be caused by my own actions or inactions, actions of others participating, weather conditions or negligence on the part of any member of **Boulder T Ranch**.
 - b. There may be other risks and social and/or economic losses either known to me or not foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I may incur as a result in my utilization of the services and facilities of **Boulder T Ranch**.
 - c. I understand that there are no medical facilities on **Boulder T Ranch** and that there may or may not be anyone who can exercise the expertise necessary to deal with any potential injuries to which I may be exposed.
- 3. HEREBY release, discharge and covenant NOT to sue Boulder T Ranch, their administrators, directors, agents, officers, volunteers, employees, other participants, owners, lessors of premises in which the hunting activities occur, (each considered "RELEASEE" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by RELEASEES or otherwise, during my stay at Boulder T Ranch through services provided inclusive of hunting activities, lodging provided and meals. I declare that I have furnished my own equipment and Boulder T Ranch has NOT supplied me with any weaponry for this hunt. I have been provided with and have read and understand the RULES AND REGULATIONS as outlined by Boulder T Ranch

I agree to be solely responsible for my safety and to take every precaution to provide for my own safety and well being while I utilizing the hunting facilities of **Boulder T Ranch**. I further understand that if it is deemed that I have caused damage to any property belonging to **Boulder T Ranch**, I will be held monetarily responsible for all replacements and/or repairs.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE COMPLETE AND AN UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
